Amended Articles of Incorporation of Passivhaus Philippines Inc.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock corporation under the laws of the Republic of the Philippines.

AND WE HEREBY CERTIFY:

First: That the name of said corporation shall be

Passivhaus Philippines Inc.

Second: <u>As amended on February 19, 2025</u>, That the purpose or purposes for which such corporation is incorporated are:

Passivhaus Philippines is a national non-profit professional association of Passive House volunteer stakeholders (architects, engineers, planners, policymakers, contractors, academe, suppliers, and public) in the Philippines. We work to promote the Passive House Standard and foster a greater public understanding of highly-energy efficient and low-carbon buildings that reduce greenhouse gas emissions and provide resilient structures that can withstand extreme weather related to climate change. Our vision is that all Filipinos live and work in healthy, comfortable, low-energy, resilient buildings by 2050. We aspire for a Philippines with highly energy-efficient and low-carbon buildings that are solutions to the world's climate change crisis. Our mission is to make the International Passive House standard of building performance understood, achievable, and adopted by stakeholders in the Philippines through education, technical support, and advocacy. The Association shall have the following objectives or purposes:

a) Training and development of professionals - To raise awareness and build capacity of Filipino designers (professional architects and engineers) and builders to become Passive House designers and tradespersons by upskilling the local industry through training and development of courses and events;

b) To increase projects in the Philippines built and certified to the Passive House standard by assisting stakeholders in delivering their projects to Passive House standard; and

c) To have Passive House standard be mandated in building code, policies, and tender specifications by lobbying and campaigning for necessary actions from governments and organizations to adopt the Passive House standard towards achieving net-zero.

Provided that the corporation shall not solicit, accept or take investments/placements from the public neither shall it issue investment contracts.

Third: That the principal office of the corporation is located in <u>UNIT 313 NATIONAL</u> ENGINEERING CENTER UNIVERSITY OF THE PHILIPPINES DILIMAN U.P. VILLAGE DISTRICT 4, QUEZON CITY, SECOND DISTRICT, NATIONAL CAPITAL REGION (NCR), 1101;

Fourth: That the corporation shall have a term of existence of <u>fifty (50)</u> years from the date of issuance of the certificate of incorporation;

Seventh: That the total contribution of the corporations is Fifty Thousand Pesos (P50,000).

Eighth: That JOHN HOWARD ACERON GARCIA has been elected by the members as Treasurer of the corporation to act as such until his successor is duly elected and qualified in accordance with the by-laws, and that as such Treasurer, he has been authorized to receive for and in the name and for the benefit of the corporation, all contributions or donations paid or given by the members.

Ninth: That no part of its income is distributable as dividends to its members, trustees or officers subject to the provisions of the Corporation Code of the Philippines on dissolution. Provided, that any profit obtained by the association as an incident to its operation shall, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provision of Title XI of the Corporation Code of the Philippines.

Tenth: That no member of the Board of Trustees shall receive any compensation or remuneration in cash or in kind for services rendered to the corporation as members.

Eleventh: That the level of administrative expenses of the corporation shall not, on an annual basis, exceed thirty percent (30%) of the total donations received and total expenses for the taxable year.

Twelfth: That in the event of dissolution, the assets of the corporation shall be distributed to another corporation, organization or association whose purpose/ purposes are similar to the purpose/ purposes of the dissolved corporation, or to the State for public purpose/purposes, or shall be distributed in accordance with an Order issued by a court of competent jurisdiction.

Thirteenth: That the incorporators undertake to change the name of the corporation, as herein provided or as amended thereafter, immediately upon receipt of notice from the Commission that another corporation, partnership or person has acquired a prior right to the use of such name, that the name has been declared not distinguishable from a name already registered or reserved for the use of another corporation, or that it is contrary to law, public morals, customs or public policy.
